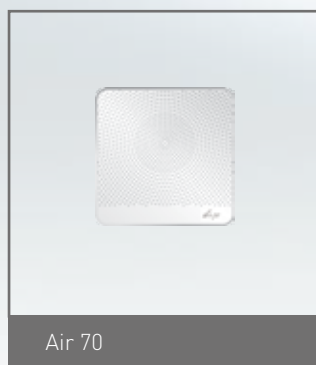
Why an extra warranty?

Brink knows from experience that the Flair, Renovent or Air 70 you purchased is a trouble-free appliance. We want you to enjoy it without any problems for many years to come. That is why we offer you the option to extend the standard warranty period for Brink appliances from 2 years to 5 years. That includes five new filter kits.

What does the extended warranty include?

The extended warranty covers the ventilation appliances Flair 325 and 400, Renovent Excellent 180, 300, 400 and 450, Renovent Sky 150, 200 and 300 and Air 70. The extended warranty includes the following:

- Five years after the installation date, free replacement of appliance parts (labour and call-out charge are excluded from this warranty).
- Repair by your own installer.
- Always genuine new Brink parts supplied.



What will you get?

In addition to the extended warranty as described above, you also receive a package of five new filter kits for the ventilation appliance. The filters must be replaced at least once a year (please refer to the description in the installation instructions at www.brinkclimatesystems.com).

What do we expect from you?

To make any claim under the extended warranty, you have to comply with the following conditions:

- The ventilationsystem has been designed, installed and maintained in accordance with the guidelines. Please refer to the description in the installation instructions at www.brinkclimatesystems.com.
- You have concluded a service contract for the appliance with your installer for a period of 5 years. He will regularly check your installation and, if necessary, clean and readjust it. He will also record the maintenance history.
- For proper performance of your installation, you must timely replace the filters in the appliance by the filter kits that came with the warranty voucher.
- Repairs are made using new and genuine parts.
- The installation must have been realised in accordance with country-specific standards.
- Otherwise, this warranty is governed by the standard Brink warranty conditions. You can find them at www.brinkairforlife.com/guarantee.

What do you have to do?

Please contact your installer for a quotation for the extended warranty and the connected maintenance contract. After your approval, he will send you the warranty voucher together with the five filter kits.

The warranty voucher bears a unique voucher number. Please return the fully completed return card in the enclosed addressed envelope to Brink Climate Systems in the Netherlands for registration of the extended warranty. Then your name will be linked to the voucher number and that makes your registration complete.
